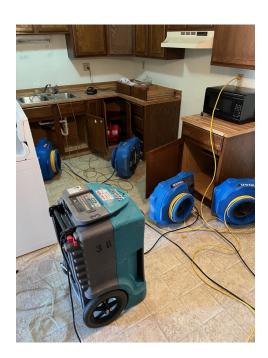


There is a saying that only two things in life are guaranteed, but in North Dakota you can add a third. Winter will bring freezing temperatures which will inevitably lead to frozen pipes. Summer time can bring thunder storms and heavy rain. But winter brings its own head-aches. From snow and salt being tracked through the hallways, to freezing pipes from the subzero weather.

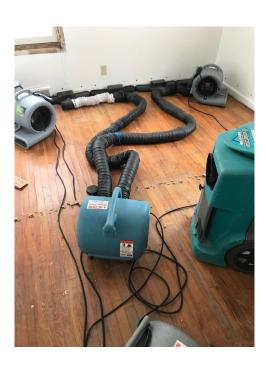
There are several things to watch out for to help prevent frozen pipes. The first is general awareness. Check to make sure all common heaters in hallways and entryways are running properly. If a resident has a window open, address it and make sure they understand the potential of frozen water lines. As the temps start to dip, a friendly reminder to residents to keep their thermostat set at 60 degrees or warmer regardless of if they are home or not. It is surprising how often residents leave for a few days and turn their heat off without realizing the damage it will cause if their water lines freeze and burst. If there is a water leak it is helpful for residents to have renters insurance as it may be their unit or a neighbor that causes the damage, but each resident is responsible for their belongings.

In the event of water damage, time is of the essence. Most building materials absorb water quickly which can cause additional issues. So first it is crucial to stop the source of water. Then remove as much water as possible. A professional restoration company has the right tools and equipment to remove the water from all types of flooring and often times can dry the carpet and pad in place, saving the cost of replacing. With air movers (fans), dehumidifiers and other specialty drying equipment most structures can be dried with minimal removal of drywall, flooring, and cabinetry. Not only does this save on the cost of repair, but also allows the resident to get their unit back in order much quicker. This is even more important now with certain building materials becoming harder to find and longer delivery times.

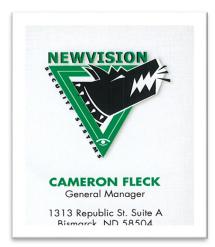

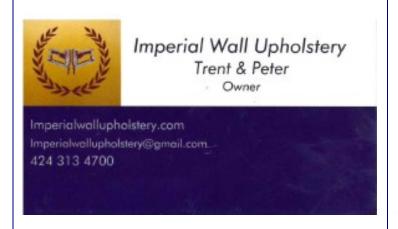
